CAMPBELL & ASSOCIATES, THE PROJECT WAS AWARDED TO THE LOW BIDDER: HORIZON UNDERGROUND, LLC FOR THE AMOUNT OF \$4,094,110.00 ON A MOTION BY MR. COOK, SECOND BY MS. BARGER. THE MOTION PASSED UNANIMOUSLY.
